**APPLICATION FOR REVIEW OF CONTEMPT**

Comes now the Respondent and requests the court to set a review of the Contempt Order in this matter.

1. Petitioner was found in contempt by this Court on May 22, 2004 and ordered to make payments as follows:


Execution of the capias is stayed as long as Petitioner pays Five Hundred and no/100 Dollars (\$500.00) each first day of every calendar month beginning June 1, 2004, plus current amounts due for maintenance of One Thousand Five Hundred and no/100 Dollars (\$1,500.00) per month and three monthly payments of Two Hundred Fifty and no/100 Dollars (\$250.00) totaling Seven Hundred Fifty and no/100 Dollars (\$750.00) as and for Respondent's attorney fees.

2. The Court's judgment as to maintenance was modified to \$1250.00 per month effective December 2004.
3. Petitioner paid the \$750.00 attorney fees directly to Respondent.
4. Petitioner paid \$ 2000.00 in maintenance to Respondent.
5. Petitioner has failed to pay the \$1750.00 as ordered by this Court.
6. Petitioner has made no payments of any kind to Respondent since November

29, 2004.

7. Petitioner has failed to provide a wage assignment as ordered by the court.
8. Petitioner filed a "bogus" petition to remove the matter to Federal Court.
9. The United States District Court has dismissed Petitioner's removal petition which should allow this Court to proceed in the Contempt matter. (See a copy of said opinion and dismissal attached hereto as Exhibit "1.")
10. Respondent has incurred substantial attorney fees to attorneys to have the Federal matter dismissed and additional fees in defense of the matter at the State Court level.
11. Petitioner remains self-employed earning a substantial wage.


Wherefore Respondent prays the Court to set a review at a date certain for further action, including the potential for incarceration (jail) of the respondent; for additional attorney fee awards
